1 Rules

- 1.1 The regatta will be governed by the current *rules* as defined in *The Racing Rules of Sailing* (RRS), the special regulations of the FIV, the rules of the International Moth Class Association (IMCA), except as any of these are altered by this Notice of Race and by the Sailing Instructions.
- 1.2 Alternative penalties: the 360° turn penalty shall apply. This modifies Rules 44.1 and 44.2 of the RRS.

2 Advertising

- 2.1 Advertising is free as the class rules (ISAF regulation 20)

3 Eligibility and Entry

- 3.1 Only current financial members of the International Moth Class Association shall be eligible to enter the regatta, and shall compete under the competitor's eligibility code set out in RRS Appendix 2.
- 3.2 The helms person named on the boat's entry form shall be the same for all races of the regatta and must be member of the IMCA for 2011.

4 Fees

- 4.1 Registration shall be done before August 15th 2011, in this case the entry fee for the regatta is € 50,00.
- 4.2 If not registered within August 15th the fee will be € 60,00.
- 4.3 Eligible boats may register by completing the online form at the Vela Club website <http://www.vccampione.org/RegateEventi/tabid/73/language/it-IT/Default.aspx> or completing the attached form and sending it by e-mail to info@vccampione.org or by fax to: +39-0365-1980186.

5 Schedule of Events

5.1 Races are scheduled as follows:

Sunday 21/08/2011	Heat 4 (start time decided on Saturday before 19.00) Heat 5 & Heat 6 (ASAP)	

5.1 On the last day of the regatta no warning signal will be made after 16.00 hours.

5.2 A copy of the Sailing Instructions will be provided at the time of registration. Registration will be undertaken at WSC.

6 Measurement

6.1 It must be demonstrated that boats have been measured and certificate issued. The regatta measurer, the IMCA executive committee, or authorised deputies may carry out measurement and safety checks on any boat at any time during the regatta.

7 Regatta Site and Sailing Area

7.1 The regatta site and sailing area is in front of Campione del Garda (Garda Lake)

8 Courses

8.1 The courses may be windward-leeward or 'p-style' as described in the Sailing Instructions.

9 Scoring

9.1 A modification of the Low Points Scoring System will be used as described in the Sailing Instructions.

9.2 6 races are scheduled of which 2 shall be completed to constitute a series.

9.3 When 3 and fewer than 3 races have been completed, a boat's series score will be the total of all her race scores.

9.4 When from 4 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

10 Prizes

10.1 Prizes may be awarded to the first three crews.

11 Buoyancy

11.1 Whilst sailing, all competitors shall wear a personal flotation device (buoyancy vest) in accordance with FIV Addendum A, regulation R1. This Amends RRS 40 and Part 4 preamble. Attention is drawn to Fundamental Rule 1.2 (Life-Saving Equipment and Personal Buoyancy).

12 Support Boats/Coaches

12.1 All support boats shall keep 100 m clear of the course area during racing, except boats provided by the organising authority or when asked to assist by the Race Committee.

13 Radio Communications

13.1 A boat shall neither make radio transmission whilst racing nor receive radio communications not available to all boats. This requirement also applies to mobile telephone communications.

13.2 A boat may use an electronic compass, provided the device does not have remote communication capabilities.

14 Rights to Use Name & Likeness

14.1 In participating in this Event, a competitor automatically grants to the Organising Authorities and the sponsors of this Event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said Event in which the competitor participates and in all material related to the said Event, without compensation.

15 Entry Disclaimer

15.1 It is the competitor's decision to enter the Event or to start and continue in any race. Competitors shall accept that their participation in the Event is at their exclusive risk in every respect. By way of entry in the Event, competitors shall indemnify the Organising Authorities, and the Host Club, their officers, members, servants and agents in respect to all claims and demands of whatever nature which may be made upon them in connection with or howsoever arising from their participation or intended participation in the Event.

15.2 Attention is drawn to Fundamental Rule 4, which states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".15.3 The Organising Authorities, and the Host Sailing Club, their officers, members, servants and agents accept no responsibility in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in the Event or howsoever arising in connection with the Event.

16 Insurance

16.1 All competing boats competing in the II° Moth & Fly Trophy, shall have third party insurance cover (which includes cover under racing conditions) with a minimum cover of € 1.000.000. All owners/competitors who sign the Entry Form are deemed to have made a declaration that they hold such cover. Competitors may be required to produce evidence of such insurance and any competitor not holding this cover shall have their entry rejected in accordance with RRS 76.1.

The race organisers and the IMCA shall not be responsible for any loss, damage, death or personal injury however caused to the owner/competitor or crew as a result of their taking part in a race or races. Moreover, every owner/competitor warrants the suitability of his or her boat for the race or races and is solely responsible for his or her decision whether or not to sail and compete in the weather conditions prevailing at the time.
